Q: What is the approximate number of business processes within the scope of the assessment?

Q: Is it GoTriangle's expectation that the selected vendor will develop detailed functional requirements to summarize business requirements for a replacement ERP solution?

Q: If the proposer does not provide system configuration and enhancement support, can they not bid on Task V? If not, can proposers submit a proposal response for Items 9.1, 9.3, and 9.4 only?
