

NOTICE OF PUBLIC HEARING
GOTRIANGLE

GoTriangle will hold a public hearing at 12:00 p.m. on Wednesday, August 26, 2026, to solicit public comments on its proposed FYs 2026 and FY 2027 Program of Projects for the utilization of Federal grant funds from the Federal Transit Administration (FTA) under Section 5307 of Title 49, United States Code. The public hearing will be held in the GoTriangle Conference Room at 4600 Emperor Boulevard, Suite 100, Durham, North Carolina.

The proposed Program of Projects (POP) is included below. This POP includes a revision of the previous POP for FY 2021-2023 5307 funds. This is also a new POP for FY 24-25 5307 funds. These revisions and additions will become final unless they are amended in response to comments received. If amended, the Final Program of Projects will be published. GoTriangle will make applications to the FTA for grant funds up to the amounts listed in the final Program of Projects.

Changes for the FY 21-23 POP increases the amount of 5307 funds used for replacement buses and preventative maintenance and less for expansion buses. The amount for engineering and construction of bus stops remains unchanged.

Amounts and funds being used are listed below:

Durham UZA 5307:

- FY 21-23: \$5,029,513
- FY 24-25: \$3,472,772

Raleigh UZA 5307:

- FY 21-23: \$4,074,209
- FY 24-25: \$3,131,731

Burlington UZA 5307:

- FY 23: \$137,947

- FY 24-25: \$280,193

Surface Transportation 5307:

- FY 25: \$909,000

TOTALS:

- FY 21-23: \$9,241,669
- FY 24-25: \$7,793,696
- TOTAL: \$17,035,365

GoTriangle expects to expend a total of \$17,053,365 in Federal Section 5307 from FY 21-25 funds for the below allowable expenditures between FY 2026-2028. Proposed project activities provide the amounts, and projected revenues are as follows:
